Even with commercial insurance coverage, the required copay amounts may still be more than most patients can afford. The Macaluso Group (TMG) works with pharmaceutical manufacturers to offer Copay Assistance Programs that make the final out-of-pocket costs for specialized medical products more affordable for the consumer. TMG was the first firm to offer patient-assistance products and services like these, and they continue to be recognized for leading technological innovations in the industry.

Pharmaceutical manufacturers deliver these specialized medical products and treatments through a variety of channels, including physician offices, hospitals, infusion centers, specialty pharmacies and traditional retail pharmacies. With solutions from TMG, copay assistance payments for these medications can be seamlessly processed as medical insurance claims, pharmacy insurance claims or through Visa or MasterCard.

As the industry sees the benefit and value TMG provides, the company’s transactions and revenue continue to grow rapidly. By offering patients a more affordable solution to access the medications they need, TMG is helping save lives every day.

## A growth in transaction volumes

From its inception, The Macaluso Group had housed its computing facilities in a traditional hosted data center. As the company continued to scale operations rapidly, and as new products were being introduced, TMG recognized it needed a more robust, flexible and scalable platform to support growth. To this end, TMG selected Amazon Web Services (AWS) as its public cloud service provider of choice.

TMG also developed new financial products and capabilities. Because they constantly manage credit card data, TMG saw tremendous value in being Payment Card Industry Data

Security Standards Level 1 (PCI DSS Level 1) compliant. Meeting this standard would demonstrate that TMG operates within the most rigorous set of security, development and operational best practices, as defined by the Payment Card Industry and as validated by an audit from a PCI-certified Qualified Security Assessor (QSA). Moreover, as a healthcare technology company, TMG has long been self-certified as HIPAA compliant. However, as part of its commitment to meet the highest level of security standards in the industry, TMG decided to engage an external auditor to verify that TGM technology, operations, and security practices meet or exceed the relevant HIPAA and HITECH requirements.

TMG sought a partner that could assist them with implementing and transitioning the company to cloud computing services while designing, building and maintaining both a PCI DSS Level 1 and HIPAA compliant environment.

## Designing the right environment

As The Macaluso Group began working with AWS to understand the capabilities and challenges of cloud computing, AWS recommended Rackspace as a trusted partner that could provide TMG with the expertise to build, manage and optimize a secure and compliant environment in the cloud.

TMG engaged Rackspace to assist in the AWS environment design and build, and to provide ongoing operations and security services for its new AWS production environment. They were also confident in Rackspace's ability to help TMG meet the requirements of both HIPAA and PCI DSS Level 1 compliance audits.

## Compliance in the cloud

Rackspace played an integral role in the design and implementation of the new AWS environment for The Macaluso Group. Initially, TMG utilized this environment to support a new product offering while continuing to use its legacy hosted environment for other products.

TMG then transitioned all computing services to AWS and to the Rackspace-managed environment. Today 100 percent of TMG production operations are hosted on the AWS cloud. Rackspace provides a broad array of operational management and security services that are critical to operations – and to maintaining PCI DSS Level 1 and HIPAA compliance for TMG.
